ARE ALL FINE AS ARE THEIR CHILDREN, BUT US
WHO STOOD BACK ARE BOTH DYING AND BOTH

my sisters children ARE sick. obviously long term exposure to any amount of these contaminants is a serious issue. ON ~~OUR~~ ^{THE} small block we live on ~~AT LEAST 59~~ of only 19 homes AT LEAST 8 or 9 people EITHER HAVE OR HAVE died of CANCER. NOT JUST CANCER BUT RARE FORMS OF CANCER, ONE young lady has CANCER of THE KNEE, A MAN HAS CANCER of THE SHOULDER, CANCER of THE NOSE, EYE, SKULL AND BRAIN. This is so important to me THAT even though i will lose a day of pay i had to go home. my medical bills are becoming a serious burden on me. AFTER my diagnosis i stopped working. but immediately began suffering crippling anxiety attacks, so i had to turn to time consuming events, one of them was coaching little league baseball 8-11 year olds. on one occasion, AT THE end of

practice. During our chalk talk the kids were playing with the dirt on the infield piling it up and throwing it in each others faces Poison!!!

while I stand with my neighbors in Porter Ranch who are obviously being affected they got the attention of the governor who declared a state of emergency

Flint Michigan whose situation is more closely related to our crisis got the attention of all these elected officials and even President BARAK OBAMA
